Please use the following for a volume calculation for our Moutray SWD release that occurred on April 9, 2024.

150 Barrel released outside Containment. 130 Recovered.

NGL was able to determine the volume by the amount the third-party vacuum trucks were able to suction up, which was 130 bbls. During the recovery process they said they were not able to recover about 10% of the released water, therefore leaving roughly 20 bbls unrecoverable.
