No injuries were associated with the incident and the fire self-extinguished. On Friday, May 17th, the Production Foreman noticed black smoke coming from the Da Vinci 7 Federal 3H facility. Upon arriving at the facility, the Foreman found the instrument air compressor was down causing the flare valve to hang wide open and allowing fluid to sweep by and out the flare. The fluid carry-over caused some damage to the electrical box and wiring. An Electrician will troubleshoot the instrument air compressor and Vaprox will repair damage to the flare.
