Steps taken to limit the duration and magnitude of vent or flare	Inlet flow reduction was active during this event and constrained wells in order to reduce the emission. Adjusted the regulators, rebuilt one of the regulators, bottom leg of the fuel skid was shut down in order to not over pressure the fuel skid until new regulators could be replaced. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared
