1. Reason why this event was beyond Operator's control:

The emissions event was caused by the unforeseen, unexpected, sudden, and unavoidable interruption, restriction, or complete shut-in of a gas pipeline by a third-party downstream pipeline operator, which impacted Oxy's ability to send gas to a third-party downstream gas pipeline. This interruption, restriction, or complete shut-in of the gas pipeline by a third-party pipeline operator is downstream of Oxy's custody transfer point and out of Oxy's control to avoid or prevent from happening and did not stem from any of Oxy's upstream facility activity that could have been foreseen and avoided, and could not have been avoided by good design, operation, and preventative maintenance practices. Oxy production technicians must assess whether the issue or circumstance is due to damage and repair is needed, or whether there are other reasons for its cause. In this case, this flaring event occurred due to an unexpected shut in and/or restriction of flow intake by Lucid, which was caused by high O2 in the gas service line. As a result of Lucid's O2 sensor detecting the high O2 and its ESD valve closing, Oxy had to flare its gas until the O2 in the gas stream was cleared.
