Please explain reason for why this event was beyond this operator's control	Cascading events starting with hydrate in HP filter sep transmitter which caused 2 compressors to go down, this in turn caused 2 compressors to go down on ROD load, High inlet pressures due to these units going down resulted in flaring.
Steps taken to limit the duration and magnitude of vent or flare	Production was cut back to mitigate flaring and control pressures. Hydrate was cleared and compressors brought back online. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared
