Please explain reason for why this event was beyond this operator's control	Salado 23 CTB required a site inspection to be performed per the requirements of an EPA-issued consent agreement and final order. As a result, the inspection led to venting from the tanks. This event exceeded the permitted SSM allowance, and therefore submitted as an excess emission.
Steps taken to limit the duration and magnitude of vent or flare	The tank inspection was performed per the requirements of an EPA-issued consent agreement and final order. No additional tank inspections are expected to fulfill CAFO requirements. Following the inspection, tank hatches and emission control equipment were returned to service as soon as practicable once the inspection was complete.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	The tank inspection was performed per the requirements of an EPA-issued consent agreement and final order. No additional tank inspections are expected to fulfill CAFO requirements.
