For this event, this operator could not have reasonably anticipated the current event and it was beyond this operator's control.	True
Please explain reason for why this event was beyond this operator's control	A faulty third-party oxygen meter was providing false readings and caused the third-party takeaway operator to shut in. This caused the facilities operating pressures to rise. The increased facility operating pressure resulted in venting from the second phase inlet vessel separator.
Steps taken to limit the duration and magnitude of vent or flare	The unexpected operation of the oxygen meter was communicated to the third-party takeaway company. The third party agreed to recalibrate the oxygen meter to prevent future issues associated with this meter. The vapor recovery unit that were affected by this unexpected operating condition were restarted to cease the venting event.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on communicating abnormal conditions to the third-party operator to address equipment issues to prevent future events and restarting affected equipment to cease the event.
