For this event, this operator could not have reasonably anticipated the current event and it was beyond this operator's control	True
Please explain reason for why this event was beyond this operator's control	1" mercer PRV not holding on the discharge scrubber blowdown line causing line to vent on VRU K710A. Leak was tagged as part of OGI survey on 10/1 and repaired on 10/24. Third party flyover detected this leak on 10/4 and reported it to Chevron on 11/27. Based on this Chevron submitted an initial NOMVF and investigated further. Upon further investigation into the release, the original incident report was amended to reflect the emission point as a vent and update the date of the release from the discovery date to the commencement date of the release. Release volumes were updated accordingly.
Steps taken to limit the duration and magnitude of vent or flare	Work order was submitted at the time of the initial OGI survey detection (10/1) and scheduled for repair within the 30-day required time period (repair completed 10/24). Leak was repaired within 24 days, within the 30-day GCPO&G requirement. Training will be provided to operations on this incident and how to prevent recurrence.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas emissions as quickly and safely as possible to minimize the duration and volume of gas vented.
