After the offload was completed, the driver did not properly close the valve on the load line. This resulted in the check valve failing to completely seat, and allowed fluids to backflow into the lined containment. All fluids remained inside the lined containment and have been recovered by a vac truck. The containment will be washed and a liner inspection will be scheduled in the coming weeks. |
