Oxy engages in respectable and good facility operation practices while also maintaining its continuous facility equipment preventative maintenance program. In this case, several compressors malfunctioned and shutdown within a 24-hour period, due to extreme weather conditions affecting the compression equipment, which in turn triggered multiple brief intermittent flaring instances to occur. The compression equipment was severely affected by the extreme cold weather conditions, which prevented the lube oil from being pumped into the compressors, causing them to run dry. Consequently, they automatically shut down due to lube no flow alarms. The facility was winterized in anticipation of extreme freezing weather conditions. Notwithstanding proper gas compressor design and operation, various forms of mechanical or technical issues can be sudden, reasonably unforeseeable and unexpected which can cause compressor unit malfunctions to occur without warning or advance notice. Compressor engines are designed to operate in a precise manner and when detonation occurs, it disrupts the operating manner and robs the compression engine of power, thus, causing an automatic shutdown of the unit.
