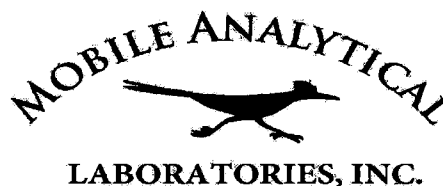

There was an unexpected released on a Targa Pipeline and for expediency, operations personnel blew the line down to the Vada Compressor Station rather than to atmosphere.
Steps taken to limit the duration and magnitude of vent or flare	Operations personnel blew the affected pipeline down as efficiently as possible.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	The line was blowdown to the flare at the Vada Compressor Station for the safety of personnel and equipment. The line will be repaired and once determined safe to operate, will be returned to service.
