#### 1. Introduction

GHD Services Inc. (GHD), on behalf of Devon Energy Production Company, LP (Devon Energy), has prepared this *Closure Report* to document site assessment activities at the Cotton Draw 14 Battery. The purpose of the assessment was to determine the presence or absence of impacts to soil following a release of crude oil within a lined containment at the Site. Based on field observations, Devon Energy is submitting this *Closure Report*, describing Site assessment activities that have occurred and requesting closure for Incident Number nAPP2503424823.

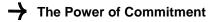
#### 2. Site Description and Release Summary

The Site is located in Unit D, Section 14, Township 25 South, Range 31 East, in Eddy County, New Mexico (32.1367521 N, -103.75341 W) and is associated with oil and gas exploration and production operations on federal land managed by the Bureau of Land Management (BLM).

On February 1, 2025, approximately 111 barrels (bbls) of crude oil were released into the lined secondary containment due to leak from a divert line from the lease automatic custody transfer (LACT) unit. A vacuum truck was dispatched to the Site to recover free-standing fluids; all 111 bbls of released crude oil were recovered from within the lined containment. The release was reported to the New Mexico Oil Conservation Division (NMOCD) on February 3, 2025, and was subsequently assigned Incident Number nAPP2503424823.

#### 3. Site Characterization and Closure Criteria

The Site was characterized to assess applicability of Table I, Closure Criteria for Soils Impacted by a Release, of Title 19, Chapter 15, Part 29 (NMAC 19.15.29) of the New Mexico Administrative Code (NMAC). Results from the characterization desktop review are summarized below and a Site Map is presented on **Figure 1**.



According to the soil survey provided by the United States Department of Agriculture National Resources Conservation Services, the soils located within the Site consists of Simona-Bippous Complex and Tonuco loamy fine sand. Per the New Mexico Bureau of Geology and Mineral Resources, the shallow geology consists of interlayered eolian sands and mixed alluvium, Holocene to middle Pleistocene in age. The Site is located within an area of low karst potential.

Depth to groundwater at the Site is estimated to be greater than 55 feet below ground surface (ft bgs) based on the nearest groundwater well data. Groundwater was determined utilizing the New Mexico Office of the State Engineers (NMOSE) database for registered water wells. The nearest permitted groundwater well with depth to groundwater data is NMOSE well is C-4912-POD1 located approximately 227 ft away on the northeastern corner of the pad location. The well was completed to a depth of 55 ft bgs on December 3, 2024. No groundwater was encountered during drilling activities or recorded during a 72-hour observation period. The well was plugged on December 9, 2024. A copy of the referenced well record is included in **Attachment A**.

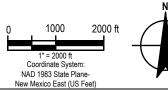
Figure 2 - Site Details Map

The nearest fresh water well for livestock watering purposes is located approximately 1.3 miles northeast of the Site. The Site is greater than 1.5 miles from a lakebed, sinkhole, or playa lake and greater than 4 miles from an occupied residence, school, hospital, institution, church. A freshwater emergent wetland is located approximately 0.64 miles northwest of the Site. The Site is greater than 1,000 feet to a freshwater well or spring. A 100-year flood zone is documented approximately 1.51 miles northwest of the Site. The nearest subsurface mine is greater than 5 miles away from the Site. The Site is not underlain by unstable geology (low potential karst designation area). The location of the Site is depicted on **Figure 1**. A detailed map of the Site is provided on **Figure 2**. The Site Characterization Documentation is included in **Attachment B**.

Based on the results of the Site Characterization desktop review, the following NMOCD Table I Closure Criteria (Closure Criteria) apply.

The liner inspection notice was provided on February 17, 2025. A liner integrity inspection was scheduled and completed on February 20, 2025, after the secondary containment was cleaned for a visual inspection. The liner was visually inspected and no rips, tears, holes, or damages in the liner was observed. The liner was determined to be intact with no integrity issues. Photographic documentation of the liner inspection is presented in **Attachment C**.

#### 5. Closure Request

Based on the liner inspection and assessment activities at the Site, Devon Energy respectfully requests that no further actions be required, and requests closure of Incident Number nAPP2503424823 be granted.

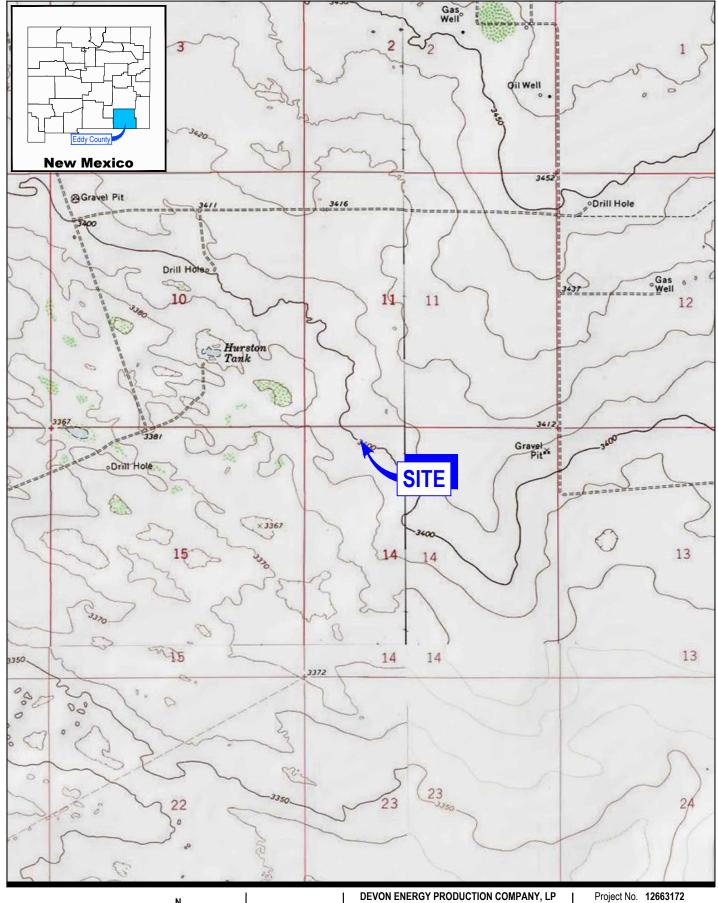

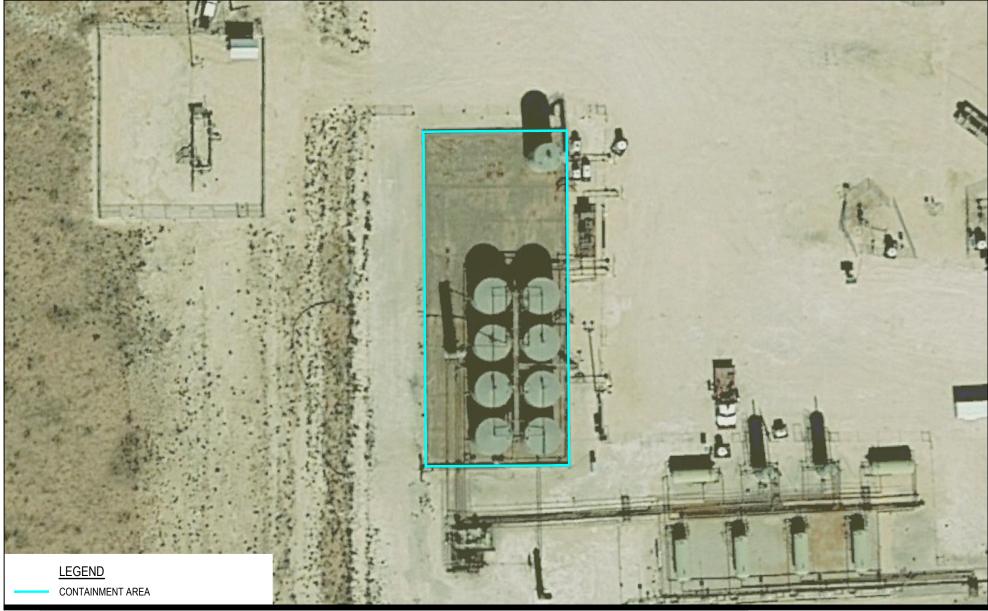

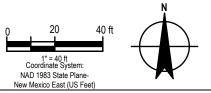

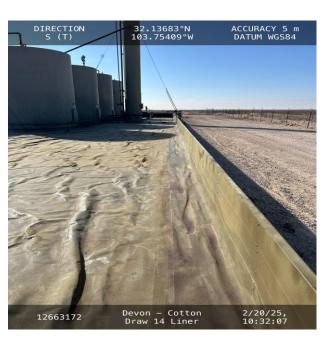

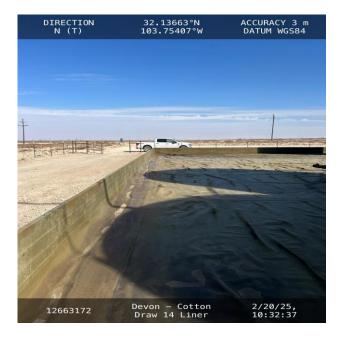

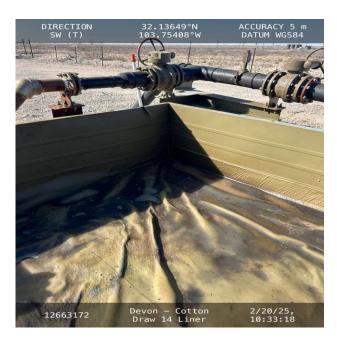

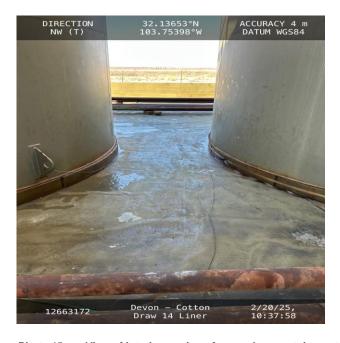

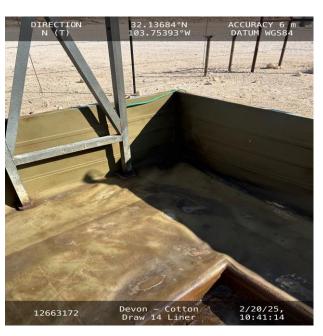


Photo 18 View of northwestern corner of secondary containment.

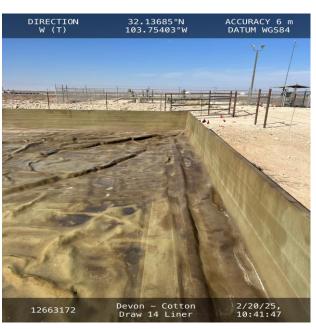


Photo 22 View of northern side of secondary containment facing west.
