Please explain reason for why this event was beyond this operator's control	Compressors at 10CS shutdown due to low fuel pressure, and then the Electric compressors shutdown due to the rapid increase in field pressure, leading to multiple flaring events. Fuel skid pressure controller malfunctioning and not able to adjust pressure fast enough for the demand.
Steps taken to limit the duration and magnitude of vent or flare	Production was cut to mitigate flaring. Steps taken to troubleshoot and fix fuel controller and then restart compressors. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared
