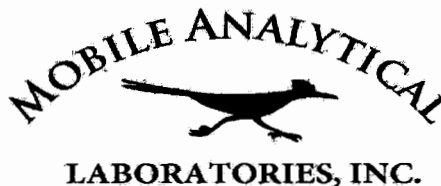

Steps taken to limit the duration and magnitude of vent or flare	Gas was flared until the takeaway malfunction was corrected, and the discharge pressure returned to normal.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Once the takeaway malfunction was corrected, normal operations resumed and flaring ceased.
