Please explain reason for why this event was beyond this operator's control	lost compressor on a faulty oil level controller switch and then lost the whole station due to a hung open dump on hot gas of fuel skid causing a station shut down and causing high corridor pressure resulting in flaring.
Steps taken to limit the duration and magnitude of vent or flare	Curtailed production, restarted compressor which stopped flaring event. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared.
