Please explain reason for why this event was beyond this operator's control	Compressor down due to PLC card vibrating loose causing an unplanned shut down of unit and then upon starting unit it went down multiple times due to one of the pneumatic valves having a bad output signal to PLC. This resulted in flaring.
Steps taken to limit the duration and magnitude of vent or flare	Production curtailed while attempts made to restart compressor. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared.
