Steps taken to limit the duration and magnitude of vent or flare	Dagger Lake lost power, causing wells to esd. Lost wells cut the gas to the field which cut off the comps. Got the field back online and flared due to inlet seeing higher pressures. All facilities and emissions control devices at this site operated as designed and, where applicable, are authorized. Chevron personnel executed practicable measures to minimize emissions. There was no risk to the public during this event.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared. Reportable quantities, process knowledge, excel spreadsheet, metered volumes, and gas analysis were used in the calculations.
