ET Gathering and Processing, LLC (Energy Transfer) is hereby justifying the volume calculations done for incident #nAPP2525432158 at the Battle Axe Compressor Station.

The volume released is a trace amount of B12 engine cleaner. At the time of the fire, the compressor was shut in for repair. Once the repair was complete, an operator cleaned the affected area with B12 engine cleaner from a spray can. Some of the spray came into contact with the hot exhaust, causing a small flash fire.
