Steps taken to limit the duration and magnitude of vent or flare	Operations personnel responded immediately to the unexpected shutdown. Gas was flared until the fiber optic cable at Eunice Middle plant was repaired.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	The fiber optic cable was repaired, units restarted and the emission event ended.
