Please explain reason for why this event was beyond this operator's control	Compressor 802 went down on High 3rd stage scrubber level and before unit could be put back online the 801 went down on high 2nd stage scrubber level 15 min later, causing brief flaring event.
Steps taken to limit the duration and magnitude of vent or flare	Couldn't get the 801 back online because the starter was bad so unit stayed down until Archrock was able to replace starter on the 801 unit. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared.
