Please provide any information necessary for navigation to sampling site	Additional soil sampling activities and excavation were conducted at the Site to address the October 8, 2019, produced water and oil release. Laboratory analytical results from all samples collected from the final release extent and release area, indicated that all COC concentrations were in compliance with the Reclamation and Closure Criteria. Based on laboratory analytical results, impacted soil exceeding the Site Reclamation and Closure Criteria has been excavated and no further remediation is required at this time. The excavation was backfilled with material purchased locally and the surface recontoured to match pre-existing Site conditions. Excavation of impacted soil has mitigated impacts at this Site. Depth to groundwater is confirmed to be greater than 100 feet bgs and no other sensitive receptors were identified near the release extent. XTO believes these remedial actions are protective of human health, the environment, and groundwater.
