### Mexico J&L Battery Spill Report

- Event Started approximately at 21:00 on Saturday night on the 23rd of January.
- Spill discovered at 16:30 Sunday afternoon on the 24<sup>th</sup> of January.
- Spill ended at 16:40. Lease operator shut production in.
- Spill composition: Produced Water.
- Spill Volume Est.: 500-600 BBLS
- Source: Mexico J&L Battery Water Tank
- Cause: Frozen transfer pump caused a high level in the water tank.
- Lease operators were not notified due to a stuck/ frozen float. No Night Lease Operator was available.
  
- At 16:45 we called for two vac trucks to remove the standing water in the containment. The trucks removed approximately 500 barrels. The lease operator was able to get the spare transfer pump running but the flow line remains frozen today. Production remains down until we can reestablish flow out there.
