We wish to change the size of our casing to the following:

We intend to drill a 10-3/4" hole to 400'. We will set 9-5/8" surface casing and drill a 8-3/4" mud drilled hole to 3,750' where we will set intermediate 7" casing. We will then drill a 6-1/4" hole to the Dakota with air. If warranted, we will run 1,800' of 4-1/2" liner as a production string.
