01/18/05 Spud @ 11:00 a.m. Drill 11" surface hole to 346'. Run 8 jts. of 8 5/8", 24#, J55 ST&C casing to 336'. Halliburton mixed and pumped 100 sx Midcon II, 14 ppg, yield 1.66. Circulate 6 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.
01/20/05 Drill 7 7/8" hole from 346' - 2,845'. Reached TD 2,845' at 12:00 noon. MIRU Patterson and log well. Logger's TD at 2,810'. Ran 66 jts of 5 1/2", 17#, J55 LT&C casing to 2,743'. MIRU Halliburton. Pumped water and gel spacer at 4 bpm, with 80 psi. Pumped 340 sks Midcon II at 13 ppg, 2.04 yield. Bumped plug with 1,235 psi. Circulated 10 bbls of cement to surface. Well shut in.
