The VPR D 152H was originally completed as a single zone horizontal lateral in the lower Vermejo coal.

The proposed plan will be to perforate the first stage at 1134'- 1139', 1192'- 1197' and the second stage at 1002'- 1004, 1032'- 1036', 1042'- 1047.

Acidize then fracture stimulate with nitrogen foam gel and approximately 72,000 lbs of brown sand. Clean out well bore, install production equipment, and return to production.
