02/05/05 Spud @ 1:00 p.m.. Drill 11" surface hole to 334'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 324'. Halliburton mixed and pumped 100 sx Midcon II, 14 ppg, yield 1.66. Circulate cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

02/06/05 Drill 7 7/8" hole from 334' - 2,650'. Reached TD 2,650' at 1:30 p.m.

MIRU Patterson and log well. Logger's TD at 2,628'.

Ran 63 jts of 5 1/2", 15.5, J55 LT & C casing to 2,592'.

MIRU Halliburton. Pumped water and gel spacer at 4 bpm, with 80 psi. Pumped 307 sks Midcon II at 13 ppg, 2.04 yield. Bumped plug with 1,279 psi. Circulated 40 bbls of cement to surface. Well shut in.
