02/16/05 Spud @ 11:00 p.m.. Drill 11" surface hole to 347'. Run 8 jts. of 8 5/8", 24#, J55 ST&C casing to 336'. Halliburton mixed and pumped 100 sx Midcon II, 14 ppg, yield 1.66. Circulate 5 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

02/17/05 Drill 7 7/8" hole from 347' - 1,495'. Reached TD 1,495' at 2:30 p.m.

MIRU Patterson and log well. Logger's TD at 1,441'.

Ran 31 jts of 5 1/2", 15.5#, J55 LT&C casing 1,423'.

MIRU Halliburton. Pumped water and gel spacer at 4 bpm, with 80 psi. Pumped 208 sks Midcon II at 13 ppg, 2.04 yield. Bumped plug with 1,282 psi. Circulated 16 bbls of cement to surface. Well shut in.
