03/03/05 Spud @ 8:00 a.m. Drill 11" surface hole to 325'. Run 7 jts. of 8 5/8", 24#, J55 ST&C casing to 315'. Halliburton mixed and pumped 100 sks Midcon II PP, 14 ppg, yield 1.66 at 4 bpm with 100 psi with 6% salt, 5#/sx gilsonite, .3% versaset and .25 #/sk flocele. Circulate 6 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

03/04/05 Drill 7 7/8" hole from 325' - 2,665'. Reached TD 2,665' at 8:45 a.m. MIRU Patterson & log well. Logger's TD at 2,631'. Ran 63 jts of 5 1/2", 15.5#, J55 LT&C casing at 2,597'. MIRU Halliburton. Pumped 362 sks Midcon II PP, 13 ppg, Yield 2.04 at 4 bpm. Plug down with 1330 psi. Float held. Circulated 7 bbls of cement to surface. Well shut in.
