03/21/05 Spud @ 6:45 a.m.. Drill 11" surface hole to 346'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 336'. Halliburton mixed and pumped 100 sx Midcon II, 14 ppg, yield 1.66. Circulate 4 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

03/22/05 Drill 7 7/8" hole from 346' - 1,975'. Reached TD 1,975' at 1:30 a.m. MIRU Patterson and log well. Logger's TD at 1,946'. Ran 47 jts of 5 1/2", 15.5, J55 LT & C casing to 1,912'. MIRU Halliburton. Pumped 250 sks Midcon II cement blend at 13 ppg, 2.04 yield. Bumped plug with 967 psi. Circulated 18 bbls of cement to surface. Well shut in.
