We propose to drill 26 inch hole to 300 ft with fresh water, run 94 lb H-40 20 inch csg and set at 300 ft with 450 sx cmt, circ to surface; drl 12 1/4 inch hole to 2000 ft with fresh water, run 36 lb J-55 9 5/8 inch csg and set at 2000 ft with 700 sx cmt, circ to surface; drl 8 3/4 inch hole to 8500 ft with cut brine water, run 23 lb N80/J55 7 inch csg and set at 8500 ft with 750 sx cmt, circ to surface; drl 6 1/8 inch hole to 11800 ft with cut brine water, run 1160 lb S-95/P110 4 1/2 inch csg and set at 11800 ft with 200 sx cmt, TOC 500 above all oil and gas bearing zones.


