Cemented with 150 sx "H" Thixad + 10#/sx Calseal + 10#/sx Gilsonite + 0.125#/sx Poly-E-Flake + 1% CaCl2 (yld 1.20, wt 14.2) and 750 sx Halliburton Lite Premium Plus "C" + 5#/sx Gilsonite + 0.125#/sx Poly-E-Flake + 1% CaCl2 (yld 1.98, wt 12.5). Tailed in with 200 sx Class "C" + 2% CaCl2 (yld 1.34, wt 14.8). Cement did not circulate. Ran 1" cement to surface with 975 sx. Tested casing to 600 psi. WOC 62 hrs.
