COG proposes to drill a 17-1/2" hole to 650' w/fr wtr mud system, wt 8.5, vis 28. Run 13-3/8" csg & cmt to surf. Drill 12-1/4" hole to 2100' w/brine mud system, wt 10, vis 30. Run 8-5/8" csg & cmt to surf. Drill 7-7/8" hole to 7000' w/ cut brine mud system, wt 9.1, vis 29-32. Test Yeso formation. Run 5-1/2" csg & cmt to surf. Note: On production string, a caliper will be run & COG will attempt to circulate cement.

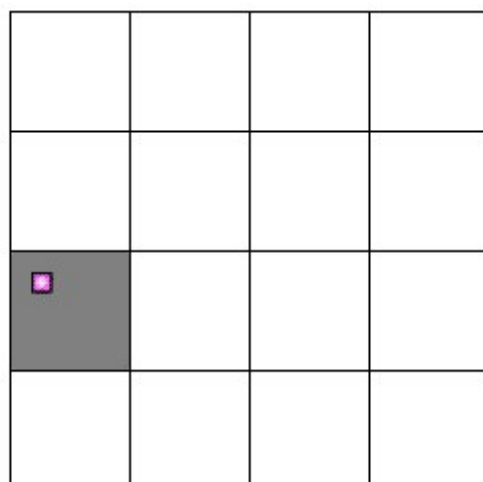
