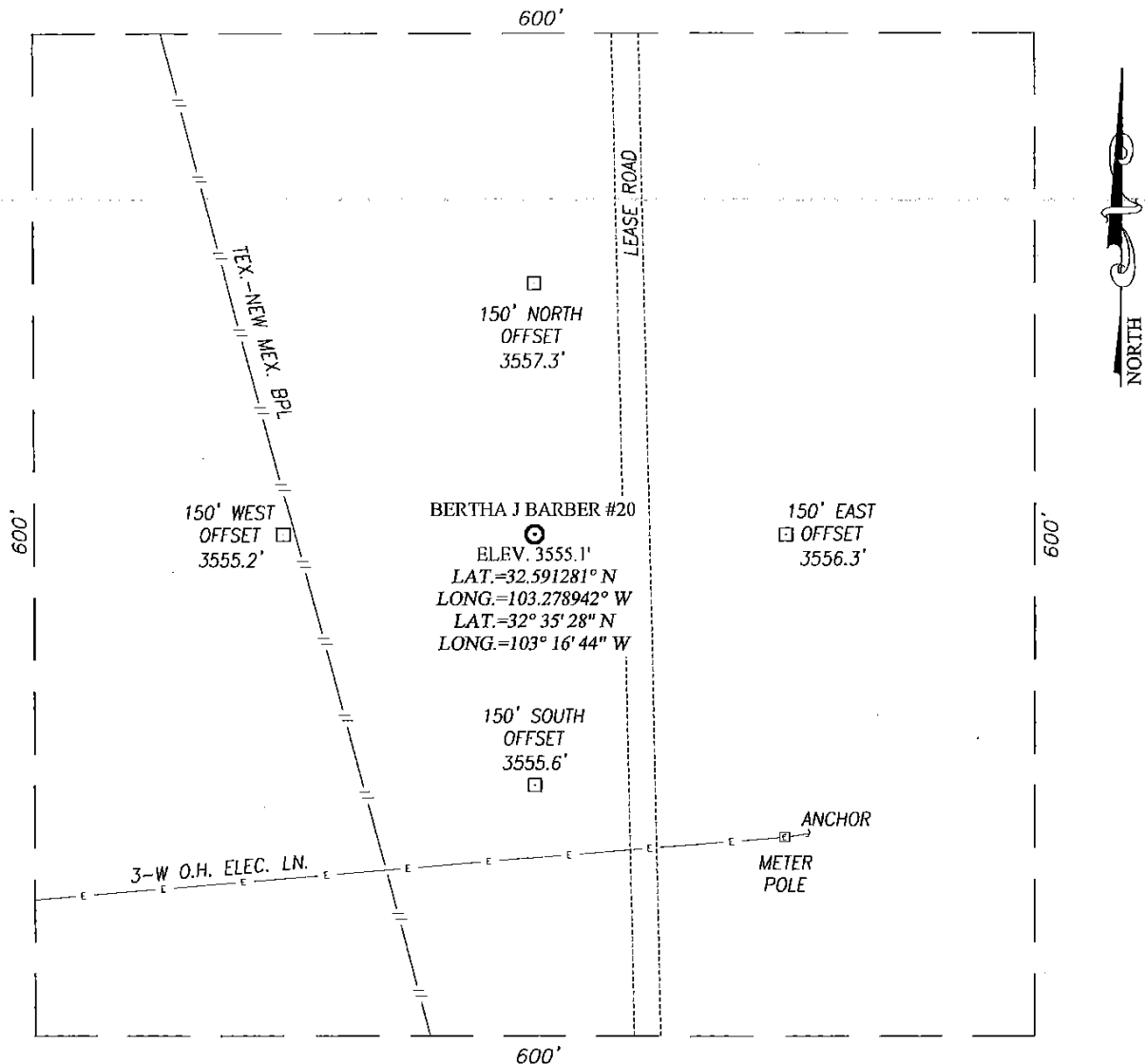

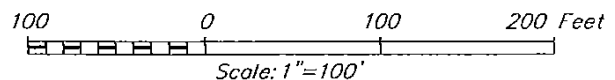

pkautz	Once the well is spud, to prevent ground water contamination through whole or partial conduits from the surface, the operator shall drill without interruption through the fresh water zone or zones and shall immediately set in cement the water protection string
pkautz	In order to seal off protectable water, surface casing must be set 25' below top of Rustler Anhydrite
pkautz	Will require administrative order for non-standard location
DMULL	Approval for drilling ONLY - CANNOT produce until Non-Standard Location is approved by OCD Santa Fe Office.
