Plan to drill a 17-1/2" hole to 380' with Fresh Water. Run 13-3/8", 48#, H-40 csg and cmt to surface. Drill 12-1/4" hole to 2410' with Brine, and run 9-5/8", 36#, J55 and cement to surface. Drill vertical to approx 7497' then kick off and drill a 7-7/8" curve and lateral with cut brine to approx 12543' MD. Run 5-1/2", 17#, P-110 csg and cement to 2000' in 1 stage.

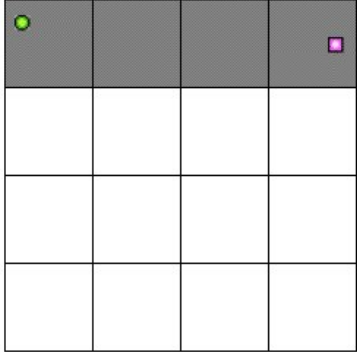
