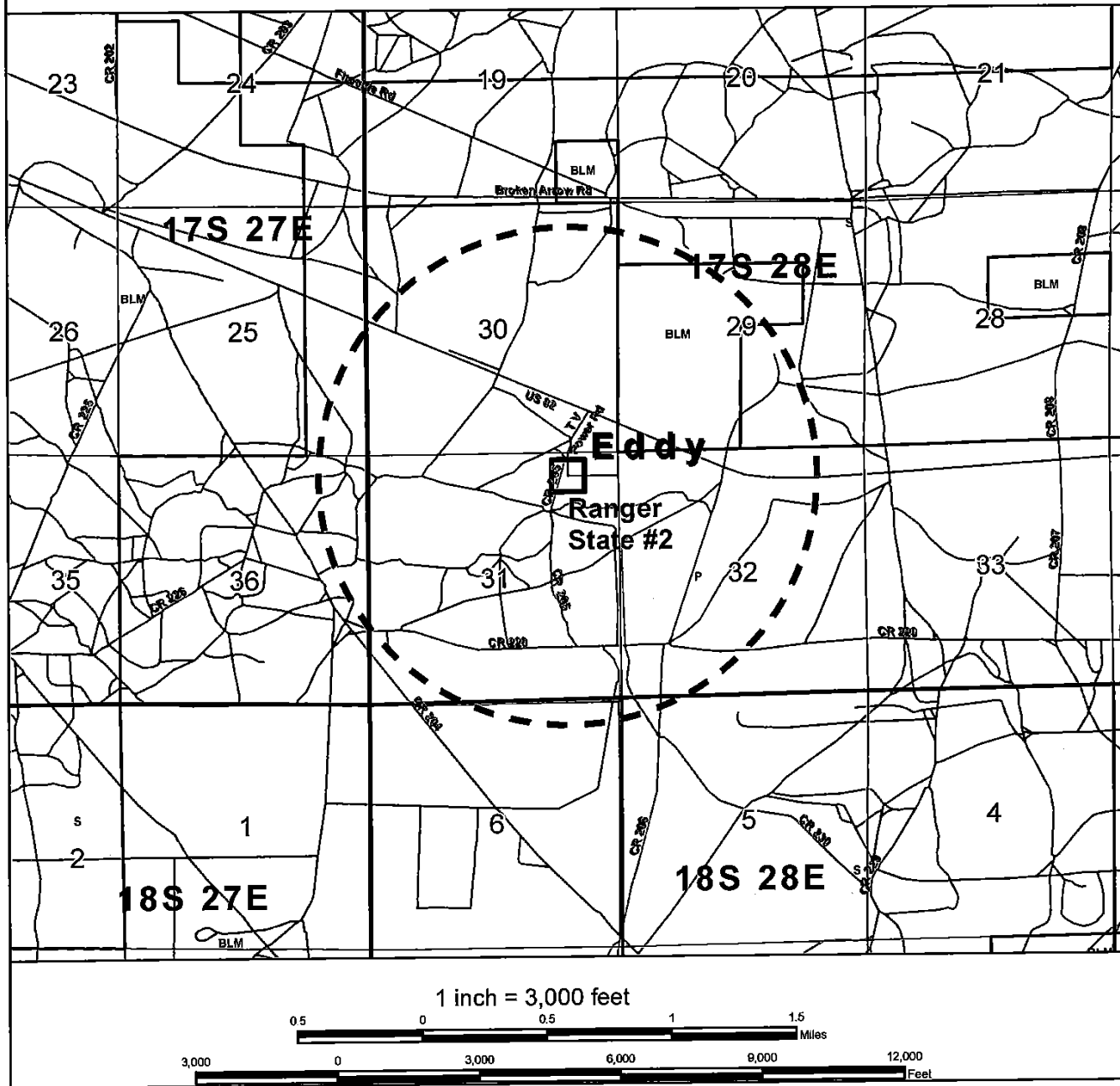

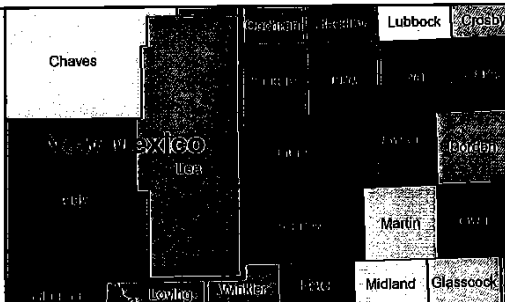


RANGER STATE #2
