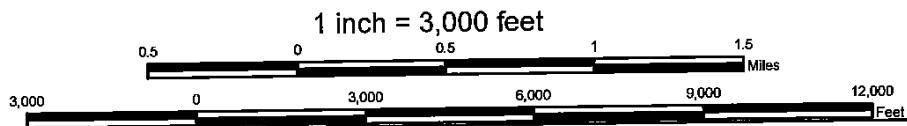
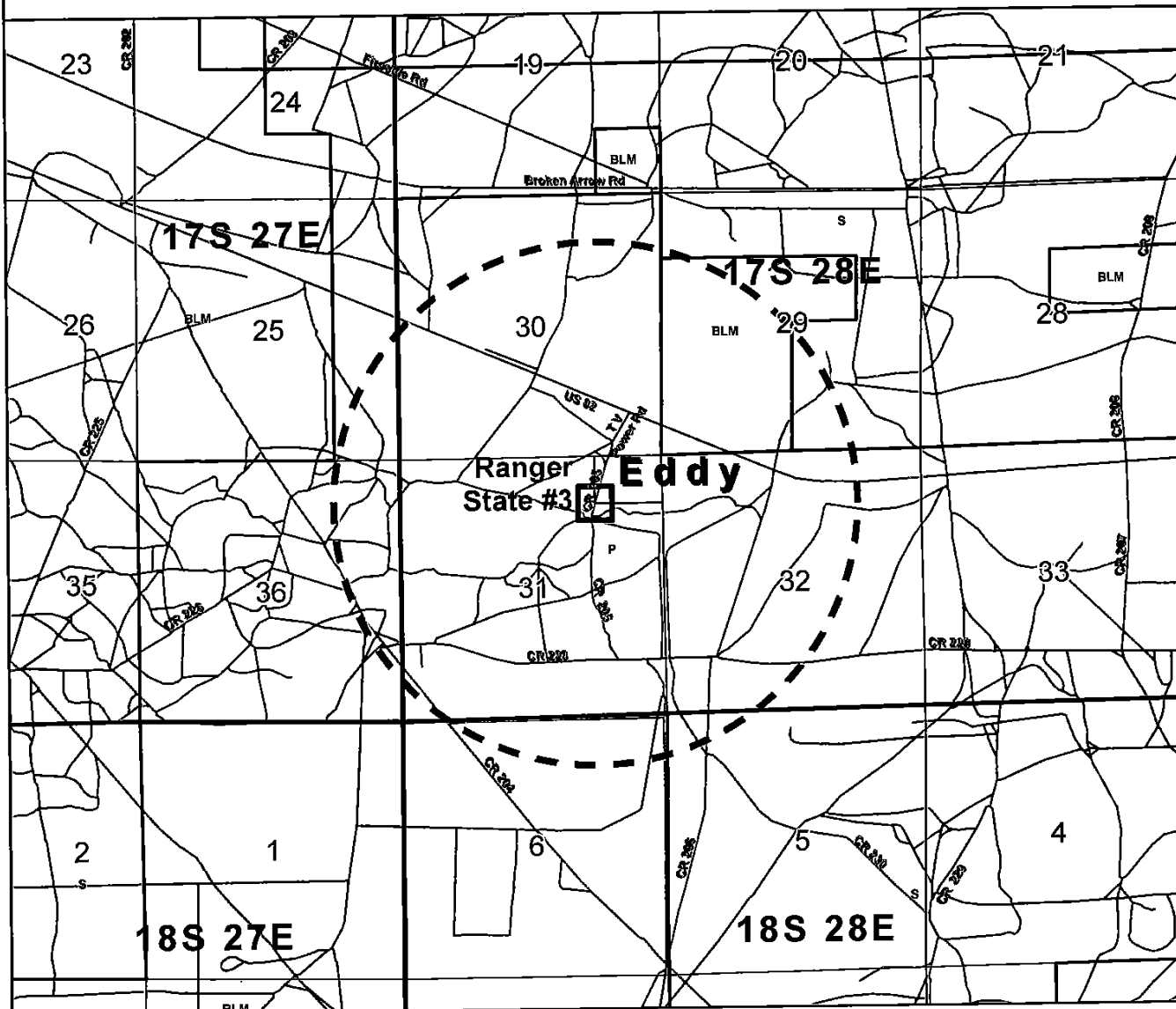

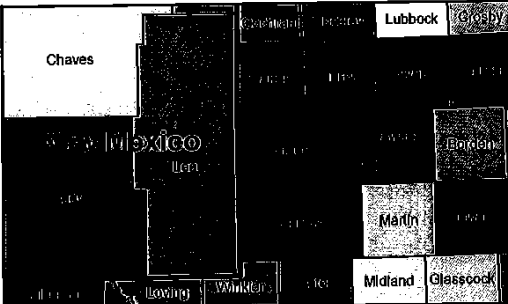


RANGER STATE #3
