A Bradenhead test was performed on Jan. 8, 2015 and filed with the New Mexico Energy, Minerals and Natural Resources Department. Tubing pressure was 570, with zero pressure in the casing and bradenhead. This well is currently TA'D because it is watered out and will not produce without artificial lift. The plan was to re-frac the well but with low oil prices the well needs to be re-evaluated for plugging and abandoning. We respectfully request another year of extension on Temporary Abandonment.
