BC OPERATING, INC, understands that the OCD's approval of this operator change;

- constitutes approval of the transfer of the permit for any permitted pit, below-grade tank or closed-loop system associated with the selected wells; and

I must file a monthly C-115 report showing production for each non-plugged well completion for which the OCD has approved an allowable and authorization to transport, and injection for each injection well. - 6, I am responsible for reporting releases as defined by 18.15.29 NMAC. I poderatand the OCD will book to me as the operator of record to take corrective action for releases at my wells and related facilities, including releases that occurred before I became operator of record.
