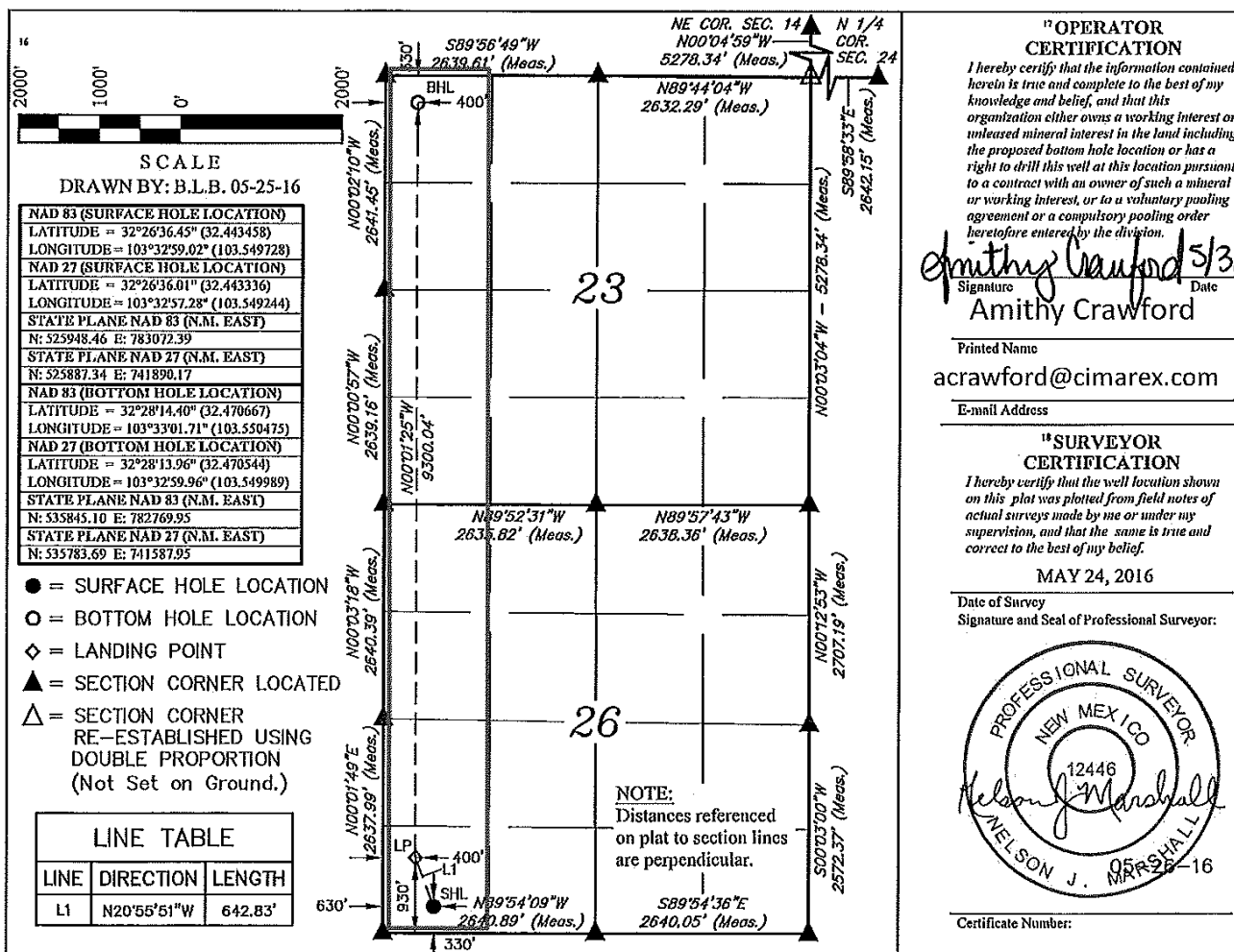

pkautz	Will require a directional survey with the C-104
