Casing/Cement Program: Additional Comments

Plan to drill a 17-1/2" hole to 700' with Fresh Water into the Rustler to cover FW water depth. Run 13-3/8", 54.5# J-55 casing and cement to surface. Drill 12-1/4" hole to 8580' with Diesel/Brine Emulsion (DBE), and run 9-5/8", 8580' of 40# N/L80 and cement to surface in one stage. Drill an 8-1/2" curve and lateral with Oil Based Mud (OBM) to approximately 21,196' MD. Run 5-1/2" 17# P110 casing to TD and cement in one stage bringing cement up to 5000' in one stage.
