Hi Lauren,

I am working on the permit to drill today.

This was a surprise, we do ask to have a heads up on applications for permit to drill in District IV.

Leonard said he talked to your dad this morning and the well was to use a Closed Loop system to drill (not an open drilling pit).

Your application has the box checked stating that Closed Loop will not be used,

Since this is a discrepancy, please confirm in writing by sending (PDF by Email) a sundry C-103 filled out the best you can showing that "Closed Loop" will be used.

Either this, or I must reject the application to drill and you will have to resubmit with another \$500 fee.

Sorry, but that is how they set up the new fee portal.

Also,

Send contact information for:

- a. Your well site company man,
- b. Your geologist watching over the operation,
- c. The landowner or surface lessee.

We try to witness all surface casing cementing jobs, so please have someone call me on my work cell (shown below) or Leonard Lowe (he will send his contact info):

- a. When the well is Spud, and
- b. 8 hours prior to cementing the surface pipe.
