12/9/2020: Run 13.375 inch 54.5 J55 casing to 1003 ft. Pump 50 bbls with CTB-15, followed by 555 sks of 13.5 ppg lead cmt, 445 sks of 14.8 ppg tail cmt. Drop plug and displace with 150 bbls of brine. 75 bbls of cement returned to surface. Pressure test casing to 1500 psi for 30 minutes, good test.

12/10/2020: Drill 12.25 inch first intermediate section to 5328 ft.

12/12/2020: Run 9.625 inch 40 lb J55 first intermediate casing to 5308 ft. Pump 20 bbls chem wash, 20 bbls vis water, followed by 1162 sks of 13.5 ppg lead cmt, 451 sks of 14.8 ppg tail cmt. Drop plug and displace with 399 bbls of freshwater. 80 bbls of cement returned to surface. Pressure test
