12/5/2020: Spud well, drill 17.5 inch surface hole to 1048 ft.
Run 13.375 inch 54.5 lb J55 casing to 1041 ft. Pump 20 bbls plexifiber, 40 bbls gel with CTB-15, followed by 845 sks of 13.5 ppg lead cmt, 600 sks of 14.8 ppg tail cmt. Drop plug and displace with 151 bbls of brine. No returns throughout entire job. Pressure tested casing to 1500 PSI for 30 minutes, good test.

Surface Casing Details: Casing ran: 12/5/2020, Fluid Type Fresh Water, Hole 17.5 inch, Csg Size 13.375 inch, Weight 54.5 lbs, Grade J55, Est TOC 0 ft, Depth set 1041 ft, Cement 1445 sacks, Yield 1.34, Class C, Pressure Held 1500 psi, Pres Drop 0.

26 stages of 14.8 ppg thixotropic class C cement in batches of 25 bbls utilizing LCM and sodium silicate.

Circulated 10 bbl of cement to surface on the final stage. Cement levels remained constant post job.

Total volume pumped 1431 bbls (~5,500 sx) (using 1.46 cuft/sk yield)
