Actual Procedure: Well spud on 1/3/2021 at 18:30 1/3/2021: Drill 17.5 inch surface hole to 1017 ft. 1/4/2021: Run 13.375 inch 54.5 lb J55 surface casing to 1007 ft. Pump 40 bbls gel with CTB-15, followed by 730 sks of 13.5 ppg lead cmt, 645 sks of 14.8 ppg tail cmt. Drop plug and displace with 146 bbls of freshwater. 270 bbls of cement returned back to surface. Did not test surface casing, will test before intermediate section is drilled.
