At that time, however, my delegation of authority to approve APDs had been temporarily suspended by the Acting Secretary of the Interior pursuant to Secretary's Order 3395. Thus, the approvals were invalid and provide no authority for operations.

The APDs are under review, and we will transmit a final decision to you as soon as possible. We will not bring enforcement actions if you have begun ground-disturbing operations in reliance on the invalid permit prior to receipt of this notice. However, such activities are unauthorized and must now cease. Please contact me if you have any questions concerning that cessation or any other questions concerning your pending permits.
