Pump 20 bbls chem wash, 20 bbls visc water, followed by 444 sks of 11.5 lead cmt, 148 sks of 13.2 ppg tail cmt. Drop plug and displace with 524 bbls of cut brine. Est TOC at 1006 ft. Pressure test casing to 2564 PSI for 30 minutes, good test.
