Actual Procedure: 02/02/2021: Drill 12.25 inch first intermediate hole to 5331 ft. 02/04/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5311 ft. Pump 20 bbls chem water, 20 bbls gel spacer, followed by 1184 sks of 13.5 ppg lead cmt, 409 sks of 14.8 ppg tail cmt. Drop plug and displace with 399 bbls of fresh water. 80 bbls of cement back to surface. Pressure test casing to 2250 PSI for 30 minutes, good test. 2/5/2021: Drill 8.75 inch second intermediate hole to 11800 ft. 2/8/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11745 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 458 sks of 11.5 lead cmt, 148 sks of 13.2 ppg tail cmt. Drop plug and displace with 537 bbls of brine. 3 bbls of cement returned to surface. Pressure test casing to 3300 for 30 minutes, good test.
