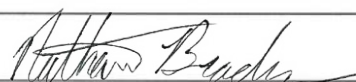
Operator will be running a 5 1/2" casing liner inside the 8 5/8" current casing.
The depths will be from surface to a downhole planned depth of ~4,250'.

Cement Details: lead cement of 350 sxs of a 85% Class C cement 15% Poz & 4% Gel (2.1 yield), and a tail cement of 100 sxs Class C neat cement (1.32 yield). These volumes account for over a 10% excess to annular volume between the 5 1/2" and 8 5/8" csg. This volume will allow us to bring cement to the surface.

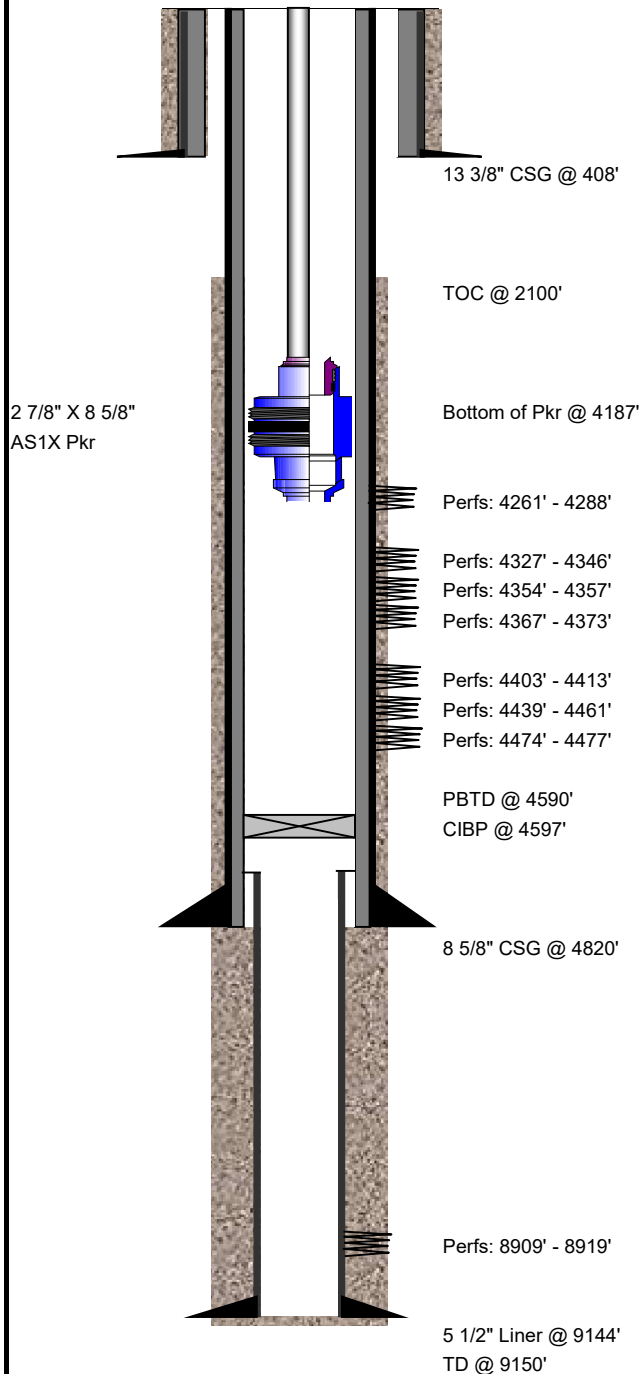
