Actual Procedure: 4/9/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 5216 ft. 4/11/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5196 ft. Pump 20 bbls chem wash, 20 bblsgel spacer, followed by 873 sks of 11.0 ppg lead cmt, 418 sks of 14.8 ppg tail cmt. Drop plug and displace with 391 bbls of freshwater. 160 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 4/12/2021: Drill 8.75 inch second intermediate hole to 11519 ft. 4/15/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11408 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 455 sks of 11.5 lead cmt, 114 sks of 13.2 ppg tail cmt. Drop plug and displace with 522 bbls of fresh water. 25 bbls of spacer returned to surface. Est TOC at 775 ft. Pressure test casing to 2550 for 30 minutes, good test.
