4/13/21 – MIRU and NU BOP. Dropped 1.25" ceramic ball. Pumped 6-1/2 bbls and pressured up to 1500 psi. Set a CIBP at 1678'. Displaced well with 35 bbls brine mud gel. Tested to 500 psi, good. Spotted 25 sx Class "C" cement on top of CIBP.

4/14/21 - Tagged TOC 1355'. Perforated at 1271'. Spotted 35 sx Class "C" cement at 1323'. WOC. Tagged TOC 880'. Spotted an 11 sx Class "C" cement plug from 103' up to surface.

4/22/21 - Cut off wellhead. Installed dry hole marker. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
